Table 1 rates apply except for applicants who have comparable health insurance, but are eligible for SCHIP because their premiums exceed 150% of SCHIP premiums. For these applicants, Table 2 rates apply for the first 6 months of coverage and Table 1 rates apply thereafter.

As a result of a Federal Grant, the premiums listed in the Discounted Rates column reflect an 5.25% reduction from the rates approved by the South Carolina Department of Insurance (DOI) for 2011. Please be aware that adjustments to these premiums may be necessary should the grant funds be exhausted prior to the end of 2011.
